On October 30th I fell at home, dislocated my shoulder and developed a hemorrhage on my knee. I spent 3 days at Sparrow Hospital where they put the shoulder back in place and started treating the knee. From there I spent 30 days at an adult therapy center in Holt learning how to walk again. I couldn't get out of bed without someone there to assist me. And anyone who has spent time in the hospital knows how a "call" button works. You press the button and someone might come in 15 minutes, 30 minutes or not at all. And if you're having an emergency, that doesn't always work very well. I had good days and bad days--started feeling sorry for myself. And sometimes wondered whether or not I would ever get to go back home again. I had a set of prayer beads with me that I used a lot and a prayer book. Eventually, either I, or God kicked me in the butt and reminded me that so many other people had much bigger problems than I.

At 9182's January meeting, I was again reminded of how lucky I have been, as during the good of the order, several of our Brother Knights asked for prayers for people who were having very severe medical issues. And the subject of prayer came up. Several Brothers mentioned how important prayers were for themselves and their loved ones. And as practical Catholic men our prayer life is taken for granted. So, I wish good health to all of our Knights and your families.

Thank you for your attention. And I would encourage all my Brother Knights to search yourselves and see if God might be encouraging you to step forward and fill our Lecturer position in the future. Fr. McGivney, Pray for us.
